This presentation of SSM/I information allows the evaluation of growing conditions in near real time for all of the world's major agricultural regions.

Commodity Hedgers' founder and CEO, Alan Basist, who was central in the development of the SSM/I wetness and temperatures algorithms, will join WeatherPredict as a Senior Scientist. Mr. Basist will maintain and expand the application of SSM/I technology in his new role.
