- These cash-settled restricted stock units were granted on March 1, 2013 under the Issuer's 2010 Restricted Stock Unit Plan (the "2010 Plan") and vest in four equal annual installments beginning on March 1, 2014.
- These cash-settled restricted stock units were granted on March 20, 2015 under the Issuer's 2010 Plan and vest in four equal annual installments beginning on March 1, 2016.
- These cash-settled restricted stock units were granted on March 15, 2016 under the Issuer's 2010 Plan and vest in four equal annual installments beginning on March 1, 2017.
